POLICY

The approved Dental Subcontractor Practice Guidelines are reviewed annually by the Vice President of Clinical Services (a licensed Oregon dentist) or their designee(s), who are licensed dentists. Additions and changes are presented to the Peer Review and Credentialing Committee for final approval. The Utilization Management Workgroup uses Practice Guidelines as part of the UM policy review process. Records of additions, changes, and/or removal of practice guidelines will be detailed in the Dental Subcontractor Peer Review and Credentialing Committee minutes.

The following practice guidelines have been reviewed and approved for implementation by the Peer Review and Credentialing Committee or all providers contracted with the Dental Subcontractor. Guidelines are to be applied based on the individual circumstances and conditions of Dental Subcontractor enrollees, in conjunction with the treating provider's professional clinical judgment. Nothing in this Policy is intended to interfere with a licensed provider's treatment decisions or clinical practice of dentistry.
