#### **PURPOSE**

This policy is the description and reporting responsibility of the Chief Ethics & Compliance Officer.

### **POLICY**

DentaQuest, the parent company of Advantage Dental Services, LLC, a Dental Care Organization (DCO), has established the position of Chief Ethics & Compliance Officer (CECO) who is responsible for overseeing and monitoring implementation of the Compliance Program, which reviews and evaluates compliance issues and concerns within the organization relating to federal and state health care programs. The CECO ensures focus on compliance with the rules and regulations of regulatory agencies, compliance with Company policies and procedures, and assurance that behavior in the organization follows the Company's standards of conduct. The CECO has direct access to the organization's leadership and other management and legal counsel and reports directly to the Audit Committee of the Board of Directors.

To assist the CECO, DentaQuest has established the Corporate Compliance Committee, charged with the responsibility and authority of operating and monitoring the Compliance Program and who report directly to the Chief Executive Officer and governing body. The DCO has also established a Compliance Committee with respect to its Oregon Medicaid line of business. This Committee reports to the Corporate Compliance Committee and includes representation from the CECO, senior level management employees and member(s) of the Board of Directors.
